Lead Team Profiles

Gerry Lennon, Head of Category Engineering Equipment, Systems and Products (EES&P)



I've been with Sellafield Ltd for over seven years, based in Warrington and Cumbria. Before joining the company I was the Head of Purchasing for ScottishPower Energy Networks for 16 years. Prior to that I worked at Ericson Telecoms and GEC in manufacturing and new product development and design.

My portfolio includes commercial management to two of the four value streams – Spent Fuel Management and Special Nuclear Materials

I am supported by category managers who take a lead on key areas: Sam States for Value Streams; Richard Taylor for Plant & Equipment; Rob McGarel for Manufactured Products and Steph Atkinson for Boxes.

Much of our work is focused on manufactured products required by Sellafield, either directly to site operations or via the PPP framework. Recently, we have increased activity and progress on a number of strategically important procurements required for site - High Integrity Stainless Steel Containers, 63 Element racks and 3m3 boxes.

During Covid-19 the team have worked to ensure the value streams are supported through re-start activities and maintaining key site-based operations. This has included undertaking risk-based analysis to ensure contingency plans are required.

The next area of focus is the formation of the Manufactured Products Intelligent Client (MPIC) organisation that will be the principle delivery mechanism for all new and existing manufactured products.

We will develop new product introductory processes to ensure all products are designed for repeatable manufacture. The team will consist of relevant Sellafield Ltd representatives and the supply chain working collaboratively via multi-discipline teams with shared objectives and outcomes.

Sellafield contract will boost local economy

A west Cumbrian company has been awarded a £30m contract to manufacture nuclear waste containers for Sellafield Ltd.

TSP Engineering, of Workington, will produce transport packages for Sellafield's decommissioning programme.

The 50-tonne, lead-lined containers will transfer nuclear waste from the legacy Magnox Swarf Storage Silo to newly built storage facilities on the site. Read the article here
